Levels of Certification

To be certified in:

Specialising in NLP Presentation Skills – you must show a basic understanding and demonstration of the course material. No prior qualifications are required for this level of certification.

Licensed Provisional Trainer -you must have a Licensed Practitioner and Licensed Master Practitioner certification from a Society of NLP – Richard Bandler Institute and show an understanding and demonstration of the course material.

To be considered for Licensed Provisional Trainer we require copies of BOTH your NLP Practitioner and NLP Master Practitioner certificates regardless of who you trained with. Make sure the seal and signatures are clearly visible. Make sure these accompany this application – otherwise your application will be placed on a waiting list until we receive them and you may lose your place in the queue. You cannot become a Licensed trainer without these documents – so make sure you send them in.

We also require a synopsis of a course you are planning to teach. This would normally be a NLP Practitioner programme but could be a different programme depending on your plans. The synopsis should include as a minimum: the length of the course, the course content for each session and the methodology you would use for your course.

To be considered for **Licensed Trainer** you must have successfully completed the Trainer training with Richard Bandler and comply with the prerequisites for Licensed Provisional Trainer outlined above. Next submit your advertising to John La Valle, before your first training, upon approval, conduct your first training, submit a short DVD of your presentation and submit all your participants for certification, if it is a Licensed Practitioner of NLP programme.

Licensing Agreements

By now we are sure that you are familiar with the process of signing Licensing Agreements. You will need to sign licensing agreements in order to be licensed and certified. Please decide which level of certification you would ideally like to achieve. Based on your application and supporting materials, your licenses will be ready for you upon registration prior to the start of the seminar.
